New System | FAQ Highlights

Do new programs apply first for Recognition and then Accreditation?

New programs must first apply and be granted Recognition status before applying for Accreditation status.

Does Accreditation+ have a site visit that is not random?

Accreditation and Accreditation+ programs will be subject to unannounced random visits; Accreditation+ will also have a required site visit within a term.

If I am a program renewing my accreditation, when will the documentation evidence need to be submitted?

Documentation submission must be submitted in the renewal window, which starts after the submission of the 4th Annual Report, and ends 6 months before the VUD, therefore programs have 6 months after they submit their 4th Annual Report to submit their documentation.
