# Learn more about the new Early Learning Program Quality Assessment and Accreditation system!

NAEYC has redesigned its accreditation system to better support early learning programs on their path to high-quality early education. The Early Learning Program Quality Assessment and Accreditation System offers a more inclusive, flexible, and streamlined model that reflects the realities of today's early learning landscape. Grounded in Developmentally Appropriate Practice (DAP) and aligned with NAEYC's Early Childhood Program Standards, this new system makes it easier for programs of all types to demonstrate and sustain quality.

#### **New System FAQ Highlights**

### Where do I find my updated accreditation certificate in the new Early Learning Hub?

Certificates are available in **the Early Learning Hub** within the "Sites and Certificates" menu item. Certificates display the program name and address included within the "Program Site" record that is listed for the program.

## What information do I need to make sure I am entering and updating in the new Early Learning Hub?

Program administrators are expected to keep their program information in the Early Learning Hub current and up to date. There are four (4) main sections within the Early Learning Hub that capture information on program.

- **General Information:** Includes information about the program status, location, enrollment by age group across the program.
  - The enrollment by age group fields are key fields used to 1) calculate the fees charged and 2) provide the program with the appropriate assessment items that will be assessed.
- **Staff:** Includes all teaching/caregiving staff; this is used to assess staff qualification assessment items.
- **Sites and Certificates:** Includes key details on the Primary location and any eligible satellites.
  - This section allows users to download the program's certificate for Recognition or Accreditation,
  - Each "Program Site" record includes key information on the location's days and hours of care, closure/exclusion dates, and other information that will be used by assessors when conducting site visits.
- Classes: Includes all active classes included in the program (and any satellites)

## If our program is deferred and regressed to Recognition, what steps do we need to take to get back to accredited status?

 Accredited or Accredited+ programs that are deferred will be regressed to Recognition after the 30-day appeal period. Once the program is regressed, it will see an option to apply for Accreditation on the "Quality Journey" widget in the Early Learning Hub.

- Programs are encouraged to reflect on the standards or assessment
  items where they did not meet the required thresholds, develop a plan of
  implementing and embedding changes to their policies, practices, etc., seek
  support if/when needed and ensure any updated policies or practices are fully
  in place prior to resubmitting.
- Programs will only encounter the Accreditation document-based assessment items within the application. If a successful decision is made on the Accreditation application, the program will advance to the Accreditation tier and can immediately apply for Accreditation+.
- After the site visit fee is paid, a site visit will be conducted where the program
  will be assessed for the Accreditation Observation-based assessment
  items. If a successful decision is received following the site visit, the program
  will be awarded Accreditation+ status and a new 5-year term.

## Previously Accredited or Waiting on a Candidacy Site Visit?

#### **Accredited Before March 2025 (Legacy Accreditation System)**

If your program is accredited under the previous system, here's what you need to know:

**Programs with Valid Until February 1, 2026** will renew under legacy system and standards.

 For legacy system information (2022 version), follow this link for information for programs that are waiting on a Candidate or Renewal Site Visit. This site includes key resources that used to be available in Torch.

**Programs with Valid Until March 1, 2026** or later will transition to the new system and standards at renewal.

 For new system information, programs can visit our website to review the new Policy Handbook and Assessment Items, including other key resources available to assist with the transition.

#### **Accredited After March 2025 (New System)**

All new applications after this date will fall under the new system and the Recognition, Accreditation and Accreditation+ tiers. Visit the new system site for more information on how to get started.
