New System | FAQ Highlights

What is the fee structure for each tier?

- New system fees are based on Tier of application and the number of children enrolled. The chart below outlines the new fees for Accreditation and Accreditation+ for a program that serves 0-60 children.

What is the benefit of doing Accreditation+ vs Accreditation?

Accreditation+ includes increased quality assurance protocols that are intended for programs that want or need increased accountability due to state or local requirements, or personal goals.

Will programs up for renewal that want to renew at the accreditation tier submit the evidence required for both recognition and accreditation? And, if they want to renew at the accreditation plus tier, would they submit evidence required for all three levels?

- Accredited programs that go through renewal (at either Accreditation or Accreditation+) in the new system will NOT encounter the Recognition assessment items, but only the Accreditation documentation items.
- Accreditation+ programs would be assessed for the Observation specific items during a planned site visit.
- Accreditation programs would be subject to a random visit throughout the term where they would be assessed for the Observation specific items.

Can non-center-based programs participate in NAEYC's Quality Assessment and Accreditation System?

Yes. NAEYC believes that high quality early childhood education can be provided in all settings, but we have been rightly held to account for the ways in which this belief has not been sufficiently reflected in our actions, and in our own systems and structures. While some FCC homes and public-school classrooms have earned NAEYC accreditation over the past decades, the ELP accreditation system had not been structured for true inclusivity. In the revised system, and in response to requests to do better with respect to inclusivity, we are working hold ourselves accountable for making ELP accreditation more accessible and equitable, expanding high-quality early learning opportunities for all children, particularly those from communities with limited access to resources.
