Digital Portfolios

Many programs have opted to use digital portfolios when gathering their evidence for Classroom and Program Portfolios. NAEYC has several recommendations to ensure the process is successful both for the program and the assessor who reviews these documents. **Here** is a digital portfolio tip sheet that is part of the Administrator Information Packet which can be found in TORCH. NAEYC also provides Word and PowerPoint templates that programs can utilize as they digitize their portfolios.
