#SOLVECHILDCARE

Since March 2020, there have been multiple rounds of federal funding to help child care providers respond to the challenges of COVID-19, including \$39 billion in the American Rescue Plan. Together, these funds have saved and stabilized child care - but they haven to solved the fundamental crisis.



TAKE ACTION

1. Review (and share with a colleague) these resources on the current status of ARP Act implementation and how you can use federal relief funds to support your child care center or family child care program.

- **ARP Act Implementation Update**: This resource from Child Care Aware shows how states are using their funding.
- <u>Map with stabilization grant applications</u>: States are in the process of making subgrant applications available to child care providers. This map provides information on stabilization subgrants and applications for each state.
- Supporting Your Child Care Business with Federal Relief Funds: This resource is available to help child care providers as you plan and use federal relief grants to support the viability of your child care business.

2. Work with your states' Affiliates and advocates to <u>center the voices of educators</u> and families. Stay persistent, engaged, and vocal!
