

Protecting Early Childhood Education in the Federal Budget Reconciliation Process

June 2025

The U.S. House of Representatives recently advanced a budget resolution that threatens deep cuts to crucial safety net programs that support early childhood educators, children, and families. As Congress moves through the budget reconciliation process, it is critical that we work together to emphasize the critical importance of investing in early childhood education and protecting these essential programs.

Here are just a few of the important programs the budget calls for massive cuts to:

- **Health care educators rely on.** The proposed bill cuts close to \$700 billion from Medicaid, which provides health insurance for nearly 28% of early childhood educators nationwide, as well as 42% of children under 6.
- **Food assistance for families and educators.** The proposed bill cuts close to \$300 billion from SNAP, which provides food assistance for low-income individuals and families, including 16% of the ECE workforce.
- **Programs that help educators access higher education.** The proposed bill cuts \$330 billion from higher education, including Pell grants, federal student loans, and other programs early childhood educators depend on to further their education.

The bill causes additional harm by shifting additional financial burdens to states, threatening their own investments in early childhood education and the ECE workforce.

Use these talking points on Medicaid

- In my state, <u>x% of early childhood educators</u> rely on Medicaid for health insurance.
- Stripping access to Medicaid would further destabilize the ECE workforce by increasing <u>early educator burnout</u> and worsening already critical workforce shortages.
- Most states rely on Medicaid to finance early intervention services. Without Medicaid, fewer children with disabilities would have access to the services that help them thrive.
- Federal Medicaid dollars make up a large portion of state budgets. Large cuts to Medicaid would threaten states' own investments in ECE and force them to make cuts to critical services families rely on.
