Every year, thanks to the great work of NAEYC Affiliates, partners, and friends, Week of the Young Child proclamations and resolutions are signed by Governors, Mayors, City Councils and more, all across America! This year, kicking off on #MusicMonday, we want all of your state and local elected officials to be singing from the same songbook, and joining the chorus to advance the early childhood education profession.



TAKE ACTION

1. Work with your <u>states' Affiliates</u> and advocates to <u>help policymakers sign</u> <u>state and local proclamations</u> that honor and advance the early childhood education profession as part of the WOYC[®].

2. <u>Put your proclamation on the map</u> once youve secured a proclamation, make sure to share it on social media using the #WOYC23. Tag the elected officials who signed them and thank them for being champions and supporters of early childhood education and educators.

EARLY CHILHOOD EDUCATORS DESERVE A THRIVING WAGE.

TOOLKIT

Low wages for early childhood educators make it hard for them to make ends meet, and put food on the table for their own families. As of February 2022, <u>one in three child care providers reported</u> <u>experiences of hunger and 29% reported not being able to afford nutritious food</u>.



TAKE ACTION

1. Read <u>NAEYC's Federal Agenda</u>, which includes recommendations for how Congress can invest in the early childhood education workforce - including by increasing compensation.

2. Show support on social media for increased wages for early childhood educators on <u>Worthy Wage Day</u>, coming up on May 1st.

3. Learn more about the Child and Adult Care Food Program (CACFP) and how it supports the health and nutrition of early childhood educators and children from our partners at <u>FRAC</u>.

APRIL 5: WORK TOGETHER WEDNESDAY

Family members' are young children's first and most important teachers. TAKE ACTION

1. <u>Raise your voice</u> as a parent or family member by telling Congress it's time to #SolveChildCare. Join educators, allies, and advocates around the country in urging Congress to make the significant, sustainable and long-term investments in affordable, high-quality child care and preschool that are urgently needed.
